The process should ensure stability of colour and flavour and the product temperature should not be warmer than -18OC. The peppers are washed several times, flash blanched, cut, and individually quick-frozen. Size 5-7mm. This specification refers to slices, which are nominally 6-8mm. The thickness will depend on the thickness of the pericarp. The pepper slices should be inspected and metal detected prior to shipment to remove foreign matter.
