• Transfer to an oven proof dish and add Arrabbiata sauce, stir and cover

• Cook in a preheated oven at 180°C/350°F/Gas Mark 4 for 30 – 35 minutes until protein is thoroughly cooked.

• Decant Arrabbiata Sauce into a suitable dip container and serve
