1. Fill EasiYo jar to halfway with room temperature drinking water (15-20°C), pour in pack contents, close lid and shake well. Add water until jar is filled to 5mm from the top and shake again.
2. Push red spacer into Yogurt Maker. Pour in boiling water (100°C) until spacer is completely covered at its highest point. Put jar inside Yogurt Maker, twist on lid, and let sit for 8-12hours.
3. Once yogurt has set, move jar to fridge to chill, then enjoy.

Unopened: Keep this pack unopened in a cool dry place (below 25°C).
